Current federal law requires that **all male** recipients of federal financial aid comply with Selective Service registration provisions. Because Selective Service has not been able to confirm your registration or your exemption status, you must complete one of the following steps. Once you have indicated which situation best applies to you, be sure to sign and date the Student Certification section at the bottom of the page and send in all required documentation. (check one)

- I certify that I am registered with Selective Service.
 - **You MUST attach a copy of your Registration Card/Registration Acknowledgement**
- I certify that I am exempt from Selective Service registration because I am female.
 - **You MUST attach a copy of your unexpired Driver's License/State Identification Card or Birth Certificate**
- I certify that I am exempt from Selective Service registration because I was born prior to January 1, 1960
 - **You MUST attach a copy of your unexpired Driver's License/State Identification Card or Birth Certificate**
- I certify that when I completed my FAFSA, I was not yet 18 years old.
- I certify that I am not required to register because I am a citizen of the Republic of Palau, the Republic of the Marshall Islands, or the Federated States of Micronesia. (If you lived in the U.S. for more than 1 year (not as a student or employee) you must register)
 - **You MUST attach proof of citizenship from specified country**
- I certify that I served on active duty in the armed forces but did not register before turning 26.
 - **You MUST attach a copy of your Certificate of Release OR a copy of your Discharge from Active Duty (DD214) (with a character of service other than dishonorable)**
- I certify that I am not required to register because I am currently on active duty in the U.S. armed services. (This does not apply to members of the Reserve and National Guard who are not on active duty)
 - **You MUST attach a copy of your active duty military I.D. OR an official letter certifying your active duty status.**
- I am under 26 years of age and have not previously registered.
 - Go to www.sss.gov; once you receive proof of registration from the Selective Service System, submit a photocopy of the proof along with this form.

If you check a box below and DO NOT have ALL the required documentation as outlined, you MUST obtain a SELECTIVE SERVICE STATUS INFORMATION LETTER from Selective Service to submit to the Office of Financial for approval. To obtain a Select Service Status Letter, you must go to www.sss.gov, print out the application and send it to Selective Service along with any supporting documentation.

- I certify that I am exempt from Selective Service registration because I first entered the U.S. after I reached the age of 26. You must submit:
 - A copy of your Arrival/Departure record (I-94) with the entry stamp on it showing the FIRST DATE OF ENTRY INTO THE U.S. **OR**
 - A copy of your passport with the entry stamp on it showing FIRST DATE OF ENTRY INTO THE U.S. **OR**
 - A copy of a letter from the U.S. Citizenship and Immigration Service (USCIS) indicating your FIRST DATE OF ENTRY INTO THE U.S.

PLEASE NOTE: A permanent resident card cannot be used as proof of entry into the United States.
- I certify that at the age of 18 and the entire time through the age of 25 I was hospitalized, incarcerated, or institutionalized.
 - Attach a copy of the institutional release papers.

THIS INFORMATION MUST COVER ALL YEARS BETWEEN AGES 18 THROUGH 25 IN IT'S ENTIRETY
- I certify that I entered the United States as a lawful nonimmigrant on a valid visa prior to reaching the age of 26 and remained in the U.S. on the terms of that visa until after the age of 26. You must submit:
 - A copy of your passport/I-94 with the entry date(s) stamp and nonimmigrant status which covers date of entry THROUGH age 25 **OR**
 - A copy of your I-20(s) or a letter from the school you attended indicating full-time attendance as a non-immigrant through the age of 25.

THIS INFORMATION MUST COVER ALL YEARS BETWEEN AGES 18 THROUGH 25 IN IT'S ENTIRETY
- I certify that at the age of 18 and through the age of 25, I was enrolled in an officer procurement program at the Citadel, North Georgia College and State University, Norwich University, Virginia Military Institute, Texas A&M University, or Virginia Polytechnic and State University.
 - Attach documentation of the dates of your enrollment, including information of the program in which you were enrolled.
- I certify that at the age of 18 and through the age of 25, I was a commissioned Public Health Service officer on active duty or was a member of the Reserve of the Public Health Service on specified active duty.
 - Attach documentation regarding your active duty, dates of duty, rank and location.
- I did not register with the Selective Service Administration by the time I reached the age of 26 for a reason other than those stated above.
 - Attach a detailed letter explaining why you did not register **AND**
 - Copies of any documentation to demonstrate your non-registration was neither willful nor intentional **AND**
 - **YOU MUST OBTAIN AND SUBMIT A SELECTIVE SERVICE STATUS LETTER**

By signing this form, I certify that all information reported on this form and within the enclosed documentation is complete and correct. Misrepresentation of facts in connection with this form may be sufficient cause, in and of itself, for cancellation or repayment of financial aid whenever discovered.
