RESULTS FROM THE TRANSITION TO TEACHING SURVEY SPRING 2022


The Transition to Teaching Survey (TTS) is administered annually, in the Spring, to graduates of Walden's initial teacher licensure programs (BS in Elementary Education and MAT in Special Education) who completed the programs during the previous academic year.

In Spring 2022, a total of 57 initial teacher licensure program graduates (BS in Elementary Education and MAT in Special Education), who completed the programs in 2020–2021, were emailed the TTS. Thirty-five (35) graduates completed the survey resulting in a 61% response rate. Of the 35 graduates responding to the survey, 24 indicated they were currently employed full- or part-time as a teacher.

Results from survey items on the TTS addressing initial licensure program graduates' ability to be hired in the education positions for which they have been prepared are presented in the pages which follow.

Graduates indicating that they had not applied for a teaching licensure either had not yet taken their state's licensure exams, had not passed their state's licensure exams, or had enrolled or plan to enroll in graduate school to pursue an additional teaching certification or endorsement.
